Your access to and use of the Site is conditional on acceptance of these Terms and Conditions.

By using this Site, you signify your agreement to these Terms and Conditions. If you do not agree to all of these Terms and Conditions of use, do not use this Site.

1 Access

1.1 The Site is only intended for individuals who can form legally binding contracts. By using the Site you are representing and warranting that you are over 18 years of age and able to enter into contracts. Do not use the Site if you do not qualify.

- (c) is otherwise inappropriate for continued access and use of the Site.

2 Content and Information

2.1 You accept that any information or material provided on the Site is general information and not intended to be, or in the nature of, advice.

2.2 You should make your own enquiries and seek independent advice from relevant professionals before acting or relying on any information or material which is made available to you on the Site.

3 Pricing and Products

3.1 All prices and fees on the Site are in Australian Dollars and are current at the time of display. Prices are subject to change and we reserve the right to alter any prices that appear on the Site at our discretion and without a reason or notice.

3.2 Products are subject to availability. We make every effort to ensure the availability of products displayed on the Site but do not warrant that all products will be available all the time.

3.3 We take every reasonable care to ensure accuracy of information on all products listed on the Site. However, this information is obtained from manufacturers or distributors and we do not accept liability for any errors in pricing and description.

3.4 You are responsible for making decisions about which products best suit your needs. Unless otherwise stated on the Site, neither O.M.A. Shopfitting Systems nor its officers, directors, employees, agents or related bodies corporate recommend or endorse or assume responsibility for any specific products, brands, methods, tests, procedures, opinions, or other information that may be available on the Site. 4 Compliance

6 Orders and Delivery

6.1 Orders will not be delivered until full payment has been received by O.M.A. Shopfitting Systems and we are satisfied with the integrity of the order.

6.2 Payment must be made using the methods provided on the Site. Payments may be made by direct debit but only after an appropriate authority has been signed by the customer before the order is made. Please contact O.M.A. Shopfitting Systems to arrange for direct debit.

6.3 We reserve the right to not provide goods or services, terminate accounts or cancel orders (or part thereof) at our sole discretion at any time. Except subject to these Terms and Conditions, we will not be held liable for loss or damage arising from the exercising of these rights.

6.4 It is your obligation to enter the correct delivery address details at time of ordering. If you enter the wrong address, we are not obliged to re-send the order to the address at our own expense.

6.5 You may request special arrangements for delivery of urgent orders in Australia or internationally. Please advise us of any arrangements when placing the order. Additional fees may apply for special arrangements.

6.6 After ordering online, you will receive an email confirmation from eWAY containing your order details (if you have provided your email address). We will attempt to send your goods within 3-5 working days. However if goods are unavailable delivery will take a little longer.

6.7 It is your responsibility to inform O.M.A. Shopfitting Systems if an order does not arrive. We will make enquiries with the courier responsible to ensure delivery as soon as possible. Any items lost in transit will be replaced at our sole discretion.

7 Returns

7.1 Faulty products ordered on the Site may be returned. Return of an item purchased will only entitle you to a store credit for the same amount. All returns are subject to acceptance of the fault by O.M.A. Shopfitting Systems and the supplier of the goods. O.M.A. Shopfitting Systems is under no obligation to accept returns products except where the product is demonstrated to be faulty or defective.

8 System Integrity and User Conduct

8.1 You must not use the Site to:

- (a) print a copy of any information contained on the Site for commercial use or on-sell information obtained from the Site;
